- c. If at any stage, it is found that a candidate does not fulfill the eligibility criteria or has furnished incorrect or false information, their candidature will be cancelled.
- d. The Textiles Committee reserves the right to cancel candidature of any candidate whose documents and claims are not found valid during verification.
- e. The final appointment will be subject to the verification of original documents, including certificates related to qualification, age, category, and other eligibility criteria.
- f. Candidates must produce all original documents and certificates at the time of document verification/interview.
- g. Failure to produce the required original documents or submission of invalid documents will lead to disqualification and removal from the selection list.
- h. The document verification will be conducted at Mumbai and the date & time for the said purpose will be informed separately.
